

**“Pieology Pizza Box Art Contest” Coloring Contest
Official Rules**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR TO WIN. PARTICIPATION CONSTITUTES ENTRANT’S FULL AND UNCONDITIONAL AGREEMENT TO AND ACCEPTANCE OF THESE OFFICIAL RULES. VOID WHERE PROHIBITED.

I. CONTEST PERIOD: The “Pieology Pizza Box” Art Contest (the “Contest”) begins on or about **11:00:01 a.m.** Pacific Standard Time (“PST”) on September 1, 2021 (“Start Date”) and ends at 11:59:59 p.m. PST on September 14, 2021 (the “Promotion Period”). The entry portion of the Contest begins on or about **11:00:01 a.m.** Pacific Standard Time (“PST”) on September 1, 2021 (“Start Date”) and ends at 11:59:59 p.m. PST on September 14, 2021 (the “Entry Period”). The Contest is sponsored by Pieology Pizzeria 2642 Michelle Drive Suite 100, Tustin, CA 92780 (the “Sponsor” and “Prize Supplier”). The official clock for purposes of the Contest is the computer of the Sponsor.

II. ELIGIBILITY: The Contest is open to legal residents of the fifty (50) United States and DC that are at least thirteen (13) years of age or older at the time of entry during the Entry Period. To participate in the Contest, the Entrant must have Internet access and an Instagram and TikTok account. Becoming an Instagram and TikTok member is free. If you are not an Instagram and TikTok member, and would like to become one, visit www.Instagram.com or www.tiktok.com. Officers, members, directors and employees of the Sponsor, and any of their respective parent companies, affiliated companies, subsidiaries, dealers, franchisees, licensees, distributors, suppliers, subsidiaries, participating retailers, advertising / promotion / judging agencies, persons engaged in the development, production or distribution of materials for this Contest (collectively, the “Released Parties”) and the immediate family members (parent, in-laws, grandparents, children, grandchildren, siblings, and spouse) of, or persons living in the same household as such individuals (whether related or not), are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. - 2) Creating their own design on a Pieology Pizza box with any art medium of their choosing. If a Pieology branded box is unavailable at your local Pieology, may substitute with a generic pizza box.
- 3) Taking a picture of their completed pizza box and uploading it to Instagram and TikTok as an original photo or video and tag **@pieology** to their post **OR** submitting by email to giveaways@pieology.com with the subject line **“Pieology Pizza Box Art Contest” Entry**.

Entrants must follow Pieology on the Instagram and TikTok platform site (www.Instagram.com or www.tiktok.com). In the event any minors below the age of 13 complete the art piece, their legal guardian can submit their completed coloring sheet, and the legal guardian will be gifted the prize should the submitted entry be chosen as the winner. By registering and submitting an entry, each Entrant certifies they have read and agree with these Official Rules. The Entrant is responsible for all costs associated with uploading the post or video. The post (photo or video) file must be uploaded to Instagram and TikTok and must conform to all file formats defined by the Instagram and TikTok application. The maximum length of a video submission is 30 seconds in duration. Limit one (1) entry per person and/or per e-mail address during the Entry Period. All entries must be received between September 1, 2021 and September 14, 2021. All required information must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of an entry. Internet entries must be made by the Entrant only. Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including, but not limited to, commercial Contest subscription notification and/or entering service sites, will be declared

Sponsor reserves the right to disqualify any person or e-mail address that submits more than maximum number of entries. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. Sponsor will be reviewing all post and story submissions.

IV. VII. PRIZE: There will be one (1) First prize available to be awarded. The First Prize winner will receive a \$100 Pieology Gift Card and pizza-themed school supplies. Prize valued at \$200. The prize will be gifted to the winner by mail. The Approximate Retail Value ("ARV") of the First Prize is \$ 200. Total Prize Pool - \$200.

VIII. CONTEST WINNER DETERMINATION: There will be two (2) rounds of judging: round 1: initial judging to determine the First Round Finalists; round 2: public voting to determine First Prize Winner. ROUND 1: The Contest finalists will be determined by the contest judge(s). Each post entry will be judged by a qualified judge (or panel of judges) selected by the Sponsor in its sole discretion whose decisions are final and binding. Each entry will be judged according to the clear relationship between the Story Entry to the Theme based upon the following criteria: relevance and adherence to the Theme, Quality of Photography, Originality, Creativity, and Degree of positivity and inspiration. The top three (3) to five (5) entries (each a "Finalist") as determined by the judge(s) will be posted on September 15, 2021 and will be available for viewing/voting until September 17, 2021. Sponsor reserves the right to select fewer than five (5) Finalists (or none at all) or to extend the Contest Entry Period if the Contest does not receive a sufficient number of eligible and qualified Entries, as determined by Sponsors in their sole discretion. Voting will be conducted in accordance with Instagram and TikTok polling terms and conditions. The First Place winner will be determined by the public voting which will select the best entry from among the Finalists; the entry that received the most votes during the Voting Period shall receive the First Place Prize. In the event of a tie, the Judges will review and determine the winner based on aforementioned criteria.

The First Prize Winner will be notified and announced on or about September 20, 2021. The potential Prize Winner is subject to verification, including without limitation, verification of eligibility, compliance with these Official Rules and completion of release form. The Sponsor will contact the potential First Prize Winner via direct messaging, telephone call and/or email. Upon verification of the Prize Winner, the prize will be sent to the address they provide.

IX. PRIZE TERMS AND CONDITIONS: The Prize Winner is required to comply with any and all applicable federal, state and local laws, rules and regulations.
